1.0 OVERVIEW UPDATE

The Nature Action Plan was adopted by the committee in March 2020 and the committee receives a standing update on progress against the plan. To date 24 of the 29 actions on the action plan have been completed (including ongoing actions).

The five outstanding actions are:

- Launch of the Tree Planting Mission (6)
- Information to be published on website promoting hedges and hedgehog holes (15)
- Engagement with landowners to connect green corridors (19)
- Creation of wildlife corridor between Bluebell Wood and Knutsford Heath (20)
- Engagement with landowners to develop Booths Mere to St John's Wood wildlife corridor (22)

An update on each is provided in the table overleaf.

2.0 NATURE ACTION PLAN PROGRESS

The Planning and Facilities Officer developed the planting plan for the winter season. The council has been awarded funding from The Tree Council to plant trees this season. The trees will be planted during February half-term utilising the same "Plant a tree with Ranger Bob" initiative as last year. ANSA will be putting forward a second batch for funding but there is no confirmed date at this stage.

3.0 OTHER RELEVANT UPDATES / INFORMATION

The Government has introduced higher fines for the felling of trees without a licence. These have been introduced as part of measures under the Environment Act 2021 and update the Forestry Act 1967. It applies to the felling of trees where a licence from the Forestry Commission is required under the latter Act and increases the fines to unlimited. This does not affect the felling of trees protected under s211 of the Town and Country Planning Act 1990 or those subject to preservation orders.

The notice of motion submitted by the Knutsford CEC Ward Councillors calling for a change in the borough council's policy of not allowing tree planting on the highway is currently listed for consideration at the Highways and Transport Committee meeting on 2nd March.

Working group members have noticed a national campaign – Trees for Streets – which aims "to make it easy for residents and organisations to donate to the planting and watering of trees in their streets and neighbourhoods". The organisation works with a number of metropolitan local authorities (e.g.

Croydon, Cambridge, Hillingdon etc) predominantly in London and at present no county unitaries.

Friends of the Moor and Friends of the Heath are hosting events as part of the RSPB Big Garden Birdwatch. The events are at 11am on Saturday 28th and Sunday 29th respectively and the Knutsford Ornithological Society will be on hand to help identify birds.
